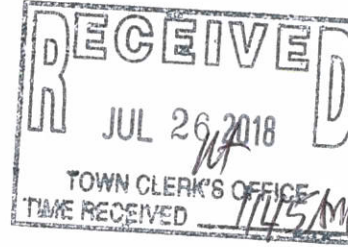




**WARRANT FOR SPECIAL TOWN MEETING
TOWN OF WARE
COMMONWEALTH OF MASSACHUSETTS**

To any of the Constables of the Town of Ware, in said County,

Greetings:

In the name of the Commonwealth of Massachusetts, you are hereby required to notify and warn all of the inhabitants of the Town of Ware, Precincts A, B and C, qualified to vote on Town affairs, to meet at the Ware High School Auditorium, 237 West Street, Ware, on Wednesday, August 15, 2018 at seven o'clock in the evening (7:00 P.M.), then and there to act on the following articles:

ARTICLE 1.

To see if the Town will vote to appropriate, borrow or transfer from available funds, an amount of money to be expended under the direction of *the School Committee* for a feasibility study to be done for the replacement of all the doors and windows at the Ware Middle School, 239 West Street, Ware MA 01082, for which feasibility study the Town may be eligible for a grant from the Massachusetts School Building Authority. The MSBA's grant program is a non-entitlement, discretionary program based on need, as determined by the MSBA, and any costs the Town incurs in connection with the feasibility study in excess of any grant approved by and received from the MSBA shall be the sole responsibility of the Town. , or take any other action relative thereto.

ARTICLE 2:


To see if the Town will vote to appropriate, borrow or transfer from available funds, an amount of money to be expended under the direction of *the School Committee* for a feasibility study to be done to replace the two boilers at the Stanley M. Koziol Elementary School, 4 Gould Road, Ware MA 01082 for which feasibility study the Town may be eligible for a grant from the Massachusetts School Building Authority. The MSBA's grant program is a non-entitlement, discretionary program based on need, as determined by the MSBA, and any costs the Town incurs in connection with the feasibility study in excess of any grant approved by and received from the MSBA shall be the sole responsibility of the Town. or take any other action relative thereto.

And you are directed to serve up this Warrant by posting attested copies thereof at the Town Hall, at the Post Office calling the same at least fourteen (14) days before the time of said meeting and also by publishing a copy of the warrant on the Town of Ware website at least fourteen days before said meeting and make due return of this Warrant with doings thereon, to the Town Clerk of Ware on or before the time of said meeting.






