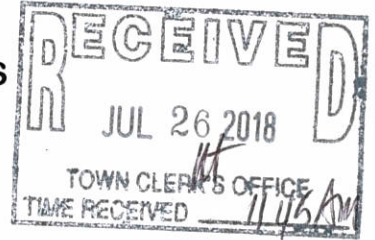

To cast their votes in the State Primaries for the candidates of political parties for the following offices:






